Sealed Bids addressed to Manager Materials (MCR), Pak-Arab Refinery Limited (PARCO), Qasba Gujrat, Mahmood Kot, Distt. Muzaffargarh, must be deposited in the Tender box placed at reception of Refinery Building up to **1430 hrs on November 28, 2018**. Bids will be opened **at 1500 hrs** on the same day in the presence of bidders or their authorized representatives, who elect to attend.

Bids must be accompanied with a Bid Bond in the form of Bank Draft or Pay Order or CDR in favour of **Pak-Arab Refinery Limited** in an amount equal to **five percent (5%) of total Bid value**. Bids submitted must remain valid for acceptance for a period of **Ninety (90) days** from the date of bid opening. Bids submitted without Bid Bond shall not be accepted. Bid bond of successful bidders who fail to make payment of bid amount or fail to lift the Material in time specified in Tender documents shall be forfeited.
